Abstract Submission: We invite you to submit an abstract based on one of the Conference Themesin this Call for Papers, or the individual calls from the Programme Committees that will follow in January 2024. Conditions for submission: By submitting an abstract you commit yourself to being able to present your work on one of the conference days. Please note that we receive more abstracts than we can accommodate in the final programme so selection is not quaranteed.

Conference Language: The language of the conference is English and all presentations will be made in English.
